

PCA-Newnan Tuition and Financial Aid Policy

Tuition & Fees

Tuition 2022-2023

Tuition Payment Incentive - \$250 per semester discount for students semester tuition paid in full within 10 days of the first day of class.

Financial Aid

Financial aid is available for K through 12th-grade students. These awards are need-based and merit based, available through Student Scholarship Organizations (SSO) partners and are intended to provide supplemental assistance.

PCA-Newnan need based financial assistance is based on the need of the family and has no bearing on our admission decisions. To be considered for tuition assistance, please contact the office for assistance. **There may be a fee for each family that applies for financial aid.**

In addition to completing the application, PCA-Newnan requires that families also submit copies of tax forms directly to one of our SSO Partner Organizations. In those cases where parents are not living together, the resources of both parents will be considered in establishing the family's level of need. The School Administration in coordination makes award decisions with our SSO Partners and other alternative school funding sources.

PCG Grants are available to certain students to assist with tuition cost. The PCG Grant is needs based and is used in combination with other funding sources. The PCG is applied after SSO Grants and Expected Family Contributions (EFC) are met. The PCG Grant is not intended to be the first source of funds for education, rather, it serves as a final options once all other sources have been expended.

Qualifications

There is no specific income level that qualifies a family for need-based aid; every case is individual. The evaluation process considers income, amount of debt, number of people in the family, and assets. The entire process is strictly confidential.

Eligibility

Need-Based Scholarships are provided on a first-applied, first-awarded basis as funds are available. To qualify for a scholarship in Georgia for 2022-23, your child must meet ONE of criteria 1-3 below PLUS number 4.

1. Your child is entering K-1st grade, OR
2. Your child attended a Georgia public school or was homeschooled for one full grading period during 2020-21, OR
3. Your child received a Georgia tuition tax credit scholarship in the previous year, AND
4. Your gross household income is lower than the following maximum amounts:

To make the scholarship application as simple as possible for parents. To prepare for the online application, you will be **required** to have the following documents and information (*all that are applicable*):

- Pay Stubs
- Workers Comp
- Social Security
- Child Support
- TANF Support
- Social Security Numbers
- Tax Return

Continuation of Financial Aid

Financial aid awards are renewable each year as long as there is a continued demonstrated need and the student maintains acceptable academic and behavioral standards. Families must reapply each year and the amount of each award may vary from year to year.
